Changes with TRREB Interboard Fees and New Subscriber Category

TRREB has announced a new price structure for interboard listing entries and edits. The following new pricing will be introduced effective **July 1**, **2020**:

- 1. Interboard listing fee: \$90 per new listing
- 2. Edits to existing interboard listings: \$25 per edit

In addition, TRREB is withdrawing from the UDSA program as of **June 30**, **2020**. To that end, TRREB will be announcing a new non-TRREB Member subscriber category in the coming weeks.


