

2020/2021 VOLUNTEER SURVEY RESULTS









City of Hamilton Vacant Home Tax

Last Wednesday at the General Issues Committee, the City of Hamilton took its first step towards embracing a Vacant Home Tax. Councillors voted to seek provincial approval of the tax before moving forward on implementation. The tax, which city staff believe will bring in \$3,321,573 net revenue during the first five years of operation, is targeted at increasing housing supply within the city by levying a 1 per cent tax on residential properties that have been unoccupied for more than six months during the preceding calendar year. The Draft Framework for the Vacant Home Tax does include exemptions for a list of situations, as well as a dispute mechanism.

RAHB President, Lou Piriano, weighed in on the vacant home tax at Hamilton's General Issues Committee meeting on February 2, 2022. Lou's delegation starts at 1:56:00

City of Burlington Housing Strategy Townhall Update

On Monday night, the City of Burlington held an open house to disclose the details of the city's Housing Strategy. The key findings are that rental housing is not meeting current or future needs, housing is not affordable and that there are not enough options along the housing spectrum. Despite

this, city planners were optimistic that solutions can be found for the city going forward.

Participants also had the opportunity to contribute to the formation of the draft vision statement for the housing strategy, and the evening was capped off with a lively Q&A on topics ranging from the missing middle, tiny homes and the coming of a comprehensive zoning by-law update.

One note was that Burlington would need to build ~250 new rental units per year to keep up with demand, though the data used to determine this figure was from 2016. Also touched on was the need to adapt housing to the changing climate through densification and respectful use of existing land.
