CREA Hosting Virtual CIPS Courses in March/April/May 2022

The Canadian Real Estate Association will be hosting virtual courses of the Certified International Property Specialist (CIPS) designation virtually in March, April and May, with more dates to be scheduled later in the year.

Over the next 30 years, the City's population will grow substantially. Based on the City's growth strategy much of the future growth to occur in the City will be through intensification. The City wants to ensure that this growth provides an appropriate mix of housing for all types of households, including families with children and larger households. In September 2021, a discussion paper was released that looked at ways to create an adequate supply of family friendly housing in all neighbourhoods across the City, especially as new higher density housing gets built.

There will be an opportunity for RAHB Members to participate in this engagement through two virtual public meetings being held on **March 23 at 6:30pm** or **March 24 at 1:30pm**. An online survey will also be available. Consultation will conclude on April 15, 2022.
